10 MOST WANTED LIST

1. An employee who was not actually injured at work
2. An employee who lies about his injuries to avoid work when an injury is healed
3. An employee who reports an accident that never happened
4. An employee who works a second job while receiving benefits and doesn't report his earnings
5. An employee who lies to his employer or to the Claim Administrator in order to receive benefits
6. An employee who files a false claim to receive medical care
7. A doctor who talks an injured worker into adding additional body parts to the claim
8. A doctor who prescribes medical equipment that the injured worker does not need
9. A doctor who tells an injured worker he or she needs more treatment even though the worker feels perfectly recovered
10. An attorney who convinces you to add claims of injuries that were not part of the original claim file

Making a knowingly false statement for the purpose of obtaining workers' compensation benefits is Insurance Fraud and it is a Felony under Insurance Code Section 1871.4. It is punishable by up to 5 years in state prison, \$50,000 fine and full restitution.
